

## **AGENDA**

- 1. Call to Order. At 4:06 pm using zoom
- 2. Roll. All members present.
- 3. Follow up to BCPUD re: county plan for development of parking ordinances. Discussion centered on Supervisor Dennis Rodoni's presentation of the county plan for the permit program at the 1/18/23 BCPUD meeting. At that time, he was joined in the discussion by Lt. Heather Rock, the Sheriff's new West County Area Commander. The permit plan appears to be moving forward. BCPUD is waiting to hear from the County Counsel as to whether they can issue the permits. BCPUD staff met with Marin County Sheriff's Office (MCSO) staff who described the responsibilities related to issuing permits. It did not appear as an administrative burden and since it would involve more work to charge fees, BCPUD Manager Blackman indicated that it would be better if the county would contribute the small dollar amount needed for the program. Supervisor Rodoni agreed to this idea. He also said that he believed that the Coastal Commission would allow the ordinance.

Supervisor Rodoni also stated, as he had before, that Measure X would not be renewed but allowed to sunset in November. Lt. Rock stated the MCSO point of view that it was not enforceable and could not continue because of that issue.

With the sunsetting of Measure X we do not have a plan for the rest of Bolinas – the county park side of Brighton and the other parts of the Measure X area. Although Wharf Road is shown to be included in the permit program it will have to abide by the parameters set by the county which would be difficult given the current street configuration and variety of uses on Wharf Road. Residents on that street would be consulted before any plan would go forward. Member Minvielle reiterated that without a plan, the town will once again most likely be inundated by campers. A permit program that only covers one half of one street is not a substitute for our current ordinance when it sunsets.

The idea of adding a 22-foot vehicle length to an ordinance came up at the board meeting. Member Hirsch was going to follow up with Supervisor Rodoni to see what would be possible. It was decided to report on this idea at the 2/15 BCPUD board meeting.

- 4. Approve Minutes of December 16, 2022 meeting (m/McParland, s/ Minvielle), all in favor.
- 5. Community Expression. Jennie Pfeiffer participated in the meeting to announce a community meeting on February 8 at the Community Center. Our committee is invited to participate as are other community projects. The main focus of the meeting would be the Waterhouse building situation. Several members said that they would participate.
