If concerns about water scarcity persist, I urge the BCPUD to **redirect its focus towards addressing excessive water usage in ornamental gardens** rather than scrutinizing the health and hygiene needs of the most vulnerable members of our community. By targeting non-essential water consumption practices, we can ensure a fair and equitable distribution of water resources while still meeting the basic needs of our residents at the Tacherra Ranch.

Furthermore, **by granting a limited water use meter under the supervision of the Bolinas Community Land Trust (BCLT), the water usage at the Tacherra Ranch can potentially be more effectively controlled.** This oversight mechanism will help ensure responsible water management practices while supporting the well-being of the residents who rely on this essential resource.

Finally, approving the Tacherra Ranch Emergency RV Trailer Park Project presents a unique opportunity to foster greater equity within our community. By providing improved living conditions and essential services to our most vulnerable residents, we take a significant step towards creating a more inclusive and fair society.
