NOTICE OF HEARING TO CONSIDER TERMINATION OF WATER SERVICE AND/OR REVOCATION OF PERMIT

Dear Mr. Ganis:

This letter is to advise you that during the 30-day period granted to you to come into compliance with the terms of your limited water use permit (see enclosed letter dated July 24, 2023) you again exceeded the maximum consumption allowed by the terms of your permit and therefore remain out of compliance with the terms of that permit. Specifically, during the 30-day period ending August 23, 2023, your water consumption was **1,880 cubic feet** (which is equivalent to **469 gallons per day**). Per the enclosed letter, you were required to reduce your water consumption between July 24, 2023 and August 23, 2023 to an amount less than 1,567 cubic feet (which is equivalent to the 391 gallons per day allowed by your limited water use permit).

As you did not come into compliance with the terms of your limited water use permit by August 23, 2023 as required by our prior notice of non-compliance, pursuant to BCPUD Resolution 312, **you are hereby notified that this matter will be referred to the BCPUD Board of Directors for a hearing on September 20, 2023 to consider the termination of your water service and/or the revocation of your limited water use permit for failure to comply with the terms of that permit.** The meeting will begin at 7:30 p.m. and you have the option of participating remotely via Zoom or in-person. You will receive a copy of the meeting agenda prior to the meeting date with the log-in instructions. (Meeting agendas also are posted on our website and mailed the Friday before the Board meeting date.)

Dear Mr. Ganis:

This letter is to advise you that BCPUD records for the billing period ending June 30, 2023 (*please see the enclosed water bill*) indicate that you exceeded the maximum quarterly water consumption allowed by the terms of your limited water use permit and are therefore out of compliance with that permit. Specifically, during the 3-month period ending June 30, 2023 your water consumption was 6,600 cubic feet (which is equivalent to 549 gallons per day). The maximum quarterly amount allowed under your limited water use permit is 4700 cubic feet (which is equivalent to 391 gallons per day).

You have 30-days from the date of this letter to come into compliance with the terms of your permit. To avoid further enforcement action by the BCPUD, you must reduce your water consumption between July 24, 2023 and August 23, 2023 to an amount less than 1,567 cubic feet (which is equivalent to the 391 gallons per day allowed by your permit). We are willing to inspect your water lines for possible leaks and otherwise work with you to develop conservation measures; please contact our office if you would like to set up an appointment. If you do not comply with the terms of your permit by August 23, 2023, please be advised that applicable BCPUD regulations provide that limited water use permits are subject to revocation for non-compliance and the BCPUD may discontinue service to a customer whose limited water use permit has been revoked. *You have a right to a hearing before the Board of Directors before a decision is made to discontinue your water service.*

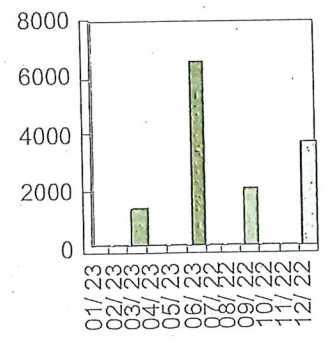

WATER BILL FOR 03/31/2023 THROUGH 06/30/2023

To calculate the gallons per day average water usage for the quarter addressed in this bill, use the following formula:

Cubic Feet Per Qtr. X 7.48 = total gallons used during this quarter.
 Divide total gallons by 90 = average Gallons Per Day during this quarter.

For example, if the Cubic Feet Per Qtr. number is 2000, your average GPD for the quarter would be 166.22 gpd
 (2000 X 7.48 = 14960. 14960 / 90 = 166.22)
