This letter is to advise you that during the 30-day period granted to you to come into compliance with the terms of your limited water use permit (see enclosed letter dated August 23, 2023) you again exceeded the maximum consumption allowed by the terms of your permit and therefore remain out of compliance with the terms of that permit. Specifically, during the 30-day period ending September 22, 2023, your water consumption was **1,352 cubic feet** (which is equivalent to **337 gallons per day**). Per the enclosed letter, you were required to reduce your water consumption between August 23, 2023 and September 22, 2023 to an amount less than 900 cubic feet (which is equivalent to the 224 gallons per day allowed by your limited water use permit).

As you did not come into compliance with the terms of your limited water use permit by September 22, 2023 as required by our prior notice of non-compliance, pursuant to BCPUD Resolution 312, you are hereby notified that this matter will be referred to the BCPUD Board of Directors for a hearing on October 18, 2023 to consider the termination of your water service and/or the revocation of your limited water use permit for failure to comply with the terms of that permit. The meeting will begin at 7:30 p.m. and you have the option of participating remotely via Zoom or in-person. You will receive a copy of the meeting agenda prior to the meeting date with the log-in instructions. (Meeting agendas also are posted on our website and mailed the Friday before the Board meeting date.)

Dear Anna:

This letter is to advise you that BCPUD records for billing period ending July 31, 2023 (see enclosed water bill) indicate that you exceeded the maximum quarterly water consumption allowed by the terms of your limited water use permit and therefore are out of compliance with that permit. Specifically, during the 3-month period ending July 31, 2023 your water consumption was 6,700 cubic feet (which is equivalent to 557 gallons per day). The maximum quarterly amount allowed under your limited water use permit is 2,700 cubic feet (which is equivalent to 224 gallons per day)

You have 30-days from the date of this letter to come into compliance with the terms of your permit. To avoid further enforcement action by the BCPUD, you must reduce your water consumption between August 23, 2023 and September 22, 2023 to an amount less than 900 cubic feet (which is equivalent to the 224 gallons per day allowed by your permit). We are willing to inspect your water lines for possible leaks and otherwise work with you to develop conservation measures; please contact our office if you would like to set up an appointment. If you do not comply with the terms of your permit by September 22, 2023, please be advised that applicable BCPUD regulations provide that limited water use permits are subject to revocation for non-compliance and the BCPUD may discontinue service to a customer whose limited water use permit has been revoked. You have a right to a hearing before the Board of Directors before a decision is made to discontinue your water service.


