Hi Max and Jennifer,

Our team thinks we have figured out a fix for the stairs, working on cost and timeline now. Thank you for bringing the situation to our attention.

Regarding the recycling bins at Wharf Road and at the end of Brighton at the beach: County Parks' contract with CCNB does not service either of these areas, as neither is Marin County Parks property. Both are DPW managed, and in talking to Chief Olivotti, because the recycling cans in both of those spots have been decorated by the community we can't really determine from the type of can or any labelling who services them – it is equally possible that DPW has them serviced, someone in the community has them serviced, or that there is no service contract and the community "self-services" them. I personally would be more in favor of Max's idea of removing them and having "pack it in, pack it out" signs, but since it is not our property, I feel like it might be a good idea if I reach out to DPW to see if I can get any more information, or at least a willingness from them to do something different.

I will circle back with updates on both of these as soon as I am able to.

I am sending a quick note to let you and your team know that the recent extreme surf/King Tides appear to have pulled out the foundational material from the final two stairs in the staircase from the County parking lot at Agate Beach down to the beach entrance.
