

Subject: Next Steps for Parking Ordinances for Bolinas

Hello Dennis, the BCPUD committee for parking met yesterday and as a result of that meeting I am following up with you about our new ordinances. I am attaching a copy of the sample ordinances that you sent me *last* February 2023 as the possible new ordinances that MCOS favored for length restrictions. These were originally proposed to be used for Measure X. Are these the ones now proposed? A recent email from Carey laid out the process for the ordinance moving forward. She said: An MOU for administration of the programs (not sure with whom), then the ordinance will be brought forward for the parking restrictions to the BOS, then signs. This information was very helpful in giving us an idea of what to expect. Thank you Carey! We do have questions.

The questions are:

*Are the two ordinances in the attached document going to be used for the length limit? Overnight 11 p.m - 5 a.m. and at all times?

*What does the permit parking ordinance look like?

We think we need to see them prior to BOS approval so that the community will know what to expect.

We also would like to know what the signs will state for the length limit and have a discussion with DPW about that step as well as placement. We have been advocating for the ordinance number to be added to existing signs where pertinent and not stated as a 22' limit on the signage. There are numerous county signs for parking restrictions which do not state the entire text of the enabling ordinance.

Re: permits, we also do need to talk to residents in the affected areas, particularly Wharf Road where the permit program plan is not fully fleshed out. We will need County help for all of this. Perhaps representatives from the BCPUD committee along with BCPUD General Manager can have a meeting with your office and DPW to go over these next steps to ensure a smooth path to implementation. Please let us know. And what the timeline is for all this to occur.

We were very glad to hear that we got past the difficult Coastal Commission hurdle. We appreciate all the work County staff have put in so far as well as your time Dennis. Looking forward to a satisfactory conclusion to this effort.


