# **MANAGERS UPDATE**

#### UPDATE ON WATER SUPPLY (20:48)

The district has received no further rain in June, so the total inches received since July 1, 2023 for the 2023-24 rain year is 35.09. The Arroyo Hondo creek flows continued to meet district demand in June and the district did not divert water from our reservoirs.

The average water production in June was 91,427 gallons per day and consumption averaged 89,043 gallons per day. Production and consumption continue on an upward trend since May. Staff shared a graph illustrating quarterly water use trends visually depicting water usage each quarter over the past 18 years.

## MEETINGS/WEBINARS ATTENDED (36:54)

Quarterly Meeting with Supervisor Rodoni. Staff Discussed several BCPUD projects that involve the County of Marin.

Staff attended a meeting with the Alliance of Coastal Marin Villages. The main topic of discussion was the project to rebuild the Point Reyes Gas Station.

SB 1383 Grant Coalition: Staff met with the coalition to discuss needs associated with the SB 1383 legislation. As a reminder, the BCPUD has received a low population waiver from CalRecycle to opt out of the need to enforce this legislation. There may be other reporting requirements needed.
