1. MANAGERS UPDATE UPDATE ON WATER SUPPLY (3:41)

The district received no rain in July, so the total inches received since July 1, 2024 (the

beginning of the 2024-25 rain year) is 0. Projected rainfall is 31.63 inches for the coming year. The Arroyo Hondo creek flows continued to meet district demand in July and the district did not divert water from our reservoirs.

The average water production in July was 115,219 gallons per day and consumption averaged 116,374 gallons per day. Production and consumption have continued on an upward trend since May. Staff shared a graph illustrating quarterly water use trends visually depicting water usage each quarter over the past 18 years.

MEETINGS/WEBINARS ATTENDED (13:20)

Quarterly Meeting with Supervisor Rodoni. Staff discussed several BCPUD projects that involve the County of Marin.

Staff met with the National Rural Water Association to assess our eligibility to qualify for Disaster Relief resiliency funding.

Staff provided an update on water leaks – there were multiple leaks throughout the district, including a large leak on the 10 inch main which required the district to shut the water off to the entire community. Staff continues to set time aside to repair the leaks.

Staff is continuing to work on various projects within the district such as: the Groundwater Wells project and Azolla management at the Woodrat 1 reservoir.
