## AGENDA

1. Call to Order. At 4:00 pm using zoom.

2. Roll. All members present.

3. Update on pending Marin County Department of Public Works (DPW) Bolinas downtown parking ordinances.

DPW submitted their plan for the Coastal Permit and local approval was obtained on November 16, 2023 from the County Zoning officer. There was a delay in review by the Coastal Commission which we had expected to be completed by 12/26. On February 15, we were notified that this review was completed and we could go forward. There are 3 proposed ordinances: a;) On the West Side of Brighton Avenue( non- residential side) No overnight parking 11 p.m.- 5 a.m of vehicles greater than 22 feet in length; b:) On Wharf Road from the Museum to the Beach, no parking at any time of vehicles greater than 22 feet in length; c:) On Brighton Avenue East side (residential side) a permit program restriction for overnight parking from 2 a.m. – 5 a.m. and d:) On Wharf Road from the Museum to the Beach the same permit restriction in an area tbd.

Upon receipt of the news DPW laid out the next steps to implementation. They are development of MOU's with administrative entities; development of ordinance language to submit to the Board of Supervisors for their approval and then signage in town. Members of the committee have only seen a possible ordinance in February 2023. The committee has asked to see the ordinances that are proposed; what the signage would look like and to review the boundaries of the permit program especially on Wharf Road where it has not been examined in detail. Committee members also expressed concern that the overnight ordinances related to length may not be sufficient enough to deal with the storage vehicles on Brighton Avenue. The ordinance seen in February 2023 limited all vehicles to the 22- foot limit which would exclude the problem vehicles.

The committee agreed to have member Hirsch and Bowser report this information to the Board on 2/28/24. Member Hirsch will send a written report prior to the meeting. She will also contact the Senior Planner at DPW to ask about the ordinances.
