




Azolla was removed 1/15 and 1/16, costing \$5,460.00; for total \$12,900 for FY 2024/2025

# Winter 2024-25 Water Usage Trends



#### PRODUCTION

- In January 2025, water *production* in the district averaged **197** gallons per day (GPD) per connection
- This is <u>UP</u> from December's production, which averaged **93** GPD per connection

#### **CONSUMPTION**

- Water *consumption* in January averaged **119 GPD** (per connection)
- This is (roughly) <u>EQUAL</u> to December consumption, which averaged **117 GPD** per connection.





 Town Consumption Estimates, based on the amount of water leaving the treatment plant daily is shown in PINK LINE.



## Operations Update (2 of 4): Storm Damage and repairs

- We are currently working with the National Park Service to get approval for this emergency work order.
- Don Murch will be helping with the repair. We are currently estimating the repair at \$6000.
- We are also looking for potential reimbursement via Marin County Office of Emergency Management.

- We still need to prepare a revised budget and request additional funds from DWR (grant funder) of >\$100K to cover our construction shortfall





## Operations Update (4 of 4): Tank-Site Pipeline Replacement project



# Governance Update (1 of 1): LAFCO Representative

- Do any BCPUD Directors have any interest in being nominated to serve as a Local Agency Formation Commission (LAFCO) representative?
- If so, the deadline for nominating you is tomorrow!
- LAFCO oversees the formation and organization of local government agencies. LAFCOs aim to:
  - Encourage orderly formation and development of local governmental agencies.
  - Preserve agricultural and open-space lands.
  - Discourage urban sprawl
- Each of California's 58 counties has its own LAFCO, which reviews proposals for the creation, expansion, or reorganization of cities and special districts to ensure efficient and logical service delivery

#### Hi All,

One Regular Special District Seat on LAFCo is up for election. As is required, a vote by mail ballot election must be held to select a member for the regular seat position, to serve a four-year term ending in May 2029. This seat is currently held by Craig Murray. His term expires in May 2025.

Ballots will be distributed by <u>February 18, 2025</u>. The candidate qualifications forms and any supportive materials will be distributed with the ballots.

The final date MCSDA will receive ballots is Monday, April 21, 2025, by 3:00 PM.

The newly selected or re-appointed candidate will be seated in time for the June 12, 2025 regular commission meeting.

## Miscellaneous Update (1 of 1): County's Public Works Projects in Bolinas:



I'll be going to the County Office to meet with Principal Civil Engineer, Robin Bartlett, at the County this Thursday:

- I'll be looking to discuss status updates on 2 projects:
  - Wharf Road & Sea Wall
  - Surfer's Overlook
- I have brought to their attention an issue we raised in BCPUD's letter to CDA regarding proposed amendments to the Local Coastal Program; I'll also be looking to discuss this issue with them further.

Excerpt from "BCPUD's December 31, 2024 letter to CDA <u>Re: Comments on Proposed Amendments to Local Coastal Program to address</u> Environmental Hazards"

II. Regarding the following section:

F. Coastal Hazards Requirements.

2. No Future Armoring. No new shoreline armoring (including but not limited to seawalls, revetments, retaining walls, gabion baskets, tie backs, piers, groins, caissons/grade beam systems, etc.) shall be constructed to protect the development approved pursuant to the Coastal Development Permit in the event that the approved development is threatened with damage or destruction from coastal hazards in the future. Any rights to construct such armoring that may exist under Coastal Act Section 30235, the Marin County LCP, or any other applicable law, shall be waived, and no portion of the approved development is an "existing structure" for purposes of Coastal Act Section 30235.

BCPUD is concerned as to how this language will impact the County's ability to pursue its two planned projects to repair its own "shoreline armors" in Bolinas, namely: (1) the cliff wall at Surfer's Overlook on Terrace Road and (2) the seawalls in the Bolinas Lagoon along Wharf Road. Is a seawall in and of itself considered a "development" in this language, and if so, what does it mean to prohibit armoring of an armament-development? Of course, both structures are preexisting, so this language may not apply as they would be characterized as "existing" developments. However, our concern here is that the project to repair the seawall along Wharf Road (which was originally planned for the Summer/Fall of 2024 and then was ultimately "postponed" for the foreseeable future) involved a total redesign and rebuild of a portion of the seawall at Wharf Road; as such, by existing LCP policy, this extensive rebuild project may not have qualified as "repair and maintenance of an existing development", and would instead have been characterized as a "new development".

It is important to understand that while Wharf Road may appear to be a small "inconsequential" road, it provides vital coastal access to the Bolinas lagoon and the Bolinas Bay. Its terminus represents the single accessible public boat launch for fishermen and seagoers in Bolinas. It is 1 of only 2 ways that the vast majority of local residents, visitors and surfers access the Bolinas beach. Due to the cordoning-off of major sink holes, where the seawall is failing, large portions of the road are down to a single lane. This has caused major traffic jams as visitors are unable to access the beach.

The BCPUD has a particular interest in ensuring that Wharf Road is maintained, as vital portions of our sewer infrastructure are located there. In addition, as the County postpones repairs of Wharf Road, and the road is allowed to fall into disrepair, seawater intrusion is corroding our water infrastructure there, leading to costly, frequent and profound water loss in our system, that even within the last 2 months, have threatened BCPUD's ability to provide safe clean drinking water to Bolinas residents.

Although BCPUD does not fully understand the way that the LCP impacts public works projects carried out by the Department of Public Works (DPW), we hope that during this amendment process, there is careful consideration as to how this language (in F.2) will impact <u>DPW's ability</u> to maintain and stabilize County roads along the coast, including, but not limited to, Olema-Bolinas Road, Wharf Road and Terrace Avenue.
