NOTICE OF INTENT to Increase Water, Sewer and Septic-Drainage Service Charges in the Bolinas Service Area Starting on July 1, 2025

April 30, 2025,

Article XIII D, Section 6, of the California State Constitution requires that the Bolinas Community Public Utility District ("BCPUD") notify you of any proposed increases in BCPUD fees/charges for the parcel number shown on the address label used for this mailing (or for the new parcel number if your property has been consolidated or merged within the past 10 months).

At the end of this letter is a summary table of the *proposed* BCPUD budget for the 2025-26 fiscal year, which begins on July 1, 2025. **If the budget is adopted by the BCPUD Board of Directors at its June 18, 2025, regular meeting, the proposed increases in the charges for water service, sewer service and septic/drainage service, detailed below, will take effect July 1, 2025.** *The County of Marin collects BCPUD's Annual Service charges and levies a fee of \$2.00 for this service. Therefore, all BCPUD water customers will be charged an additional \$2.00 per parcel.*

Proposed Increase to the Annual Water Service Charge. The proposed *annual* increase in the service charge for water is \$187, which represents a ten percent (10%) increase over the existing charge. If approved, the annual service charge for water service will increase from \$1,866 per year to \$2,053 per year.

Proposed Increase to the Quarterly Metered Water Delivery Charge. The proposed increase for quarterly metered water delivery charge is 25% across all Usage Tiers:

**In 2024 85% of our customers were in Tier 1, 11% were in Tier 2, 3% in Tier 3, 1% in Tier 4 and 5, and less than 1% were in Tier 6 and 7.

Proposed Increase to the Annual Sewer Service Charge. The proposed *annual* increase in the service charge for sewer is \$185, which represents a ten percent (10%) increase over the existing service charge. If approved, the annual service charge for residential sewer service will increase from \$1,847 per year to \$2,032 per year. The annual service charge for commercial sewer service will increase from \$1,872 - \$2,398 per year to \$2,057 - \$2,583 per year.

Proposed Increase to the Annual Septic/Drainage Service Charge. The proposed *annual* increase in the service charge for septic/drainage is \$45, which represents a one hundred and twenty nine percent (129%) increase over the existing service charge. If approved, the annual service charge for septic/drainage service on the Gridded Mesa will increase from \$35 per year to \$80 per year.

Please note that the value of these proposed increases is subject to change during the budget process.

The BCPUD has determined it is necessary to increase charges for water service, sewer service and septic/drainage service in order to continue to provide high quality services to our customers in accordance with all applicable regulatory requirements. These increases will enable the district to: (1) design, plan and install important capital improvement projects; (2) repay its debts and (3) keep up with inflation, including but not limited to the soaring price increases charged by vendors and suppliers in recent years. The BCPUD Board of Directors is in the process of updating the district's Five-Year Capital Improvement Plan, a copy of which is available on the district's website (www.bcpud.org), which sets forth the specific capital improvement projects planned across the district's enterprises for the upcoming fiscal year, as well as the four fiscal years thereafter. The Five-Year Capital Improvement Plan is updated annually, approved by the Board of Directors, and posted on the BCPUD's website.

Reasons for the proposed increase in the annual water service charge and quarterly metered water delivery:

One of the BCPUD's core missions is to provide safe and reliable drinking water to our water customers every day of the year. To do so, the BCPUD must operate, maintain and enhance its water system infrastructure. The proposed increase to water charges is needed to fund water system improvements, operations, maintenance, and repair projects planned for implementation during the 2025-26 fiscal year and meet rising costs in all areas of BCPUD water operations as reflected in the draft budget posted on our website. In addition, the proposed increase to the annual water service charge is necessary to replenish reserves that have been depleted due to the repair of several costly leaks in our aging distribution system. Quarterly metered water delivery charges have not been increased since July 1, 2009. The proposed increase will enable the district to implement near and long term planned capital improvement projects, including but not limited to repair and rehabilitation of the Arroyo Hondo Access Road, the West Tank Rehabilitation Project, the completion of the district's emergency groundwater well projects, as well as supplement the water system's financial reserves for future planned capital improvement projects.

Reasons for the proposed increase in the annual sewer service charge: Another of the BCPUD's core missions is to provide safe and reliable sewer service to our sewer customers every day of the year. To do so, the BCPUD must operate, maintain and enhance its sewer system infrastructure. The proposed increase to the annual service charge is needed to fund sewer system improvements, operations, maintenance, and repair projects planned for implementation during the 2025-26 fiscal year and meet rising costs in all areas of BCPUD sewer operations as reflected in the draft budget included in this notice. In addition, the proposed increase to the annual sewer service charge is necessary to enable the district to implement near-term planned capital improvement projects, including but not limited to new manholes and the commencement of a five-year feasibility study for upgrades to the district's wastewater treatment plant (per regulatory requirements imposed by the Regional Water Quality Control Board), as well as supplement the sewer system's financial reserves for future planned capital improvement projects.

Reasons for the proposed increase in the annual septic/drainage charge: A third mission of the BCPUD is to facilitate implementation of the “Todd Drainage Plan”. (To learn more about the Todd Drainage Plan and the septic drainage program see <https://bcpud.org/community/drainage/>). To promote optimal drainage across the Gridded Mesa, the maintenance of the dirt roads, ditches and culverts adjacent to properties on the Mesa is required. Proper management of the drainage network on the Gridded Mesa is intended to lower the water table and, ideally, improve septic system function. (High water tables can impair septic system performance). While the annual service charge for the Septic/Drainage program was \$140 in 2015-2016, it has been decreased in recent years; currently it is \$35. Today’s funding levels are not sufficient to run the program effectively. The proposed annual service charge for the 2025-2026 of \$80 is intended to begin the process of getting the program back to its original funding levels so that the BCPUD can better fulfill its responsibility to improve drainage on the Gridded Mesa. Additionally, in the 2025-26 fiscal year we plan to purchase mobile equipment that will greatly facilitate this drainage work.

There will be a public hearing on the draft budget and the proposed service charge increases at the June 18, 2025, regular meeting of the BCPUD Board of Directors. The meeting will begin promptly at 6:00 p.m., in the Bolinas Fire House Meeting Room (100 Mesa Road, Bolinas, CA 94924). You may also attend by phone or via Zoom (the meeting link and phone number will be provided on the meeting agenda which will be published on June 13, 2025, and available on the district's website: www.bcpud.org. **Approval of the fiscal year 2025-26 budget is tentatively scheduled for right after the public hearing item, at the June 18, 2025, regular meeting of the BCPUD Board of Directors, following further public discussion at that meeting.**

Instruction for Filing a Formal Protest Prior to the Close of the Public Hearing

You have the right to protest the proposed increase to rates and fees. The proposed rates cannot be adopted if written protests are received from a majority of affected parcels. Customers may file a written response, protesting the proposed maximum rate increases.

Pursuant to California law, protests must be submitted in writing and must:

- a) Identify the affected property or properties, such as by address, Assessor's Parcel Number, or customer account number;
- b) Include the name and signature of the property owner or customers submitting the protest; and
- c) Indicate opposition to the proposed water, sewer, and septic/drainage program rate increases.

Protests submitted by e-mail, facsimile or other electronic means are not considered valid written protests. Only one protest will be counted per parcel. Written protests can be mailed to: **BCPUD, P.O. Box 390, Bolinas, CA 94924**, or hand delivered to **270 Elm Rd. Bolinas, CA**. All protests must be submitted prior to the close of the Public Hearing on June 18, 2025. If you wish to protest the proposed rate increase during the public hearing, you will be asked to provide the information above in writing, and the District will document that information as a formal protest. Pursuant to California Government Code Section 53759, there is a 120-day statute of limitations for any judicial action or proceeding challenging any new increase or extended water or sewer fee or charge.
