The members of the BCPUD’s Board of Directors are elected by registered voters in the district to serve staggered four-year terms. Elections are conducted by the County of Marin and candidates for the Board stand for election in November of even-numbered years. Regular meetings of the Board of Directors are usually held on the 3rd Wednesday of the month, at the Bollinas Fire Department Meeting Room, 100 Mesa Road, Bollinas, and are open to the public. All board meetings begin a **6:00 p.m.**
