Subject: Request for Waiver of Limited Water Use Permit (L1) Requirement 105 Terrace Ave

Dear BCPUD Board Members,

I am writing to formally request a waiver of the Limited Water Use Permit (L1) requirement in connection with the emergency relocation and repair of my home located at 105 Terrace Ave.

This project is being undertaken due to save our home as a result of a landslide disaster. The home is not being expanded, and there will be no increase in square footage, bedroom count, plumbing fixtures, or occupancy. Water usage will remain consistent with historical levels associated with the existing service connection prior to the home being evacuated 2.5 years ago.

While the project includes the installation of a new septic system, it is a coderequired replacement necessary to bring the system up to current environmental and public health standards. It is not designed to increase wastewater capacity or facilitate any increase in water use. The system will continue to serve the same number of bedrooms as the prior system, with no change in fixture count. The purpose of the replacement is to restore safe and lawful use of the existing residence, not to expand it.

Given that:

- There is no increase in water demand or intensity of use,
- There is no precedent for requiring L1 for prior septic replacement projects
- The water service connection and use history remain unchanged,
- The septic system is a non-discretionary, like-for-like replacement, and
- This is a time-sensitive emergency restoration project,

I respectfully request that the District waive the L1 requirement under these circumstances. Thank you for your time and consideration.

Hi Belle

Can you provide me documentation on exactly what an L1 is? What is the requirement for having to apply for an L1?

This project is a result of a natural disaster. We are being forced by the county to install a new septic system. It doesn't sound like there is any precedent for requiring an L1 for projects that don't include any expansion, or additional bathrooms or fixtures, also doesn't sound like it's been required in the past for new septic systems. It sounds like staff is taking the position that a new septic system increases water use because it requires testing? Is there any data on that, would seem that this would be an insignificant amount of water? It would seem that there needs to be a clear legal definition of what triggers an L1.

Attached is a will-serve letter for 105 Terrace, along with a Limited Water Use Permit Application (LWUP).

BCPUD regulations require that property owners apply to the BCPUD for a water use permit whenever they

make changes to their property that require a Marin County coastal, building and/or use permit (see noted section in attached will-serve letter). The purpose of the BCPUD's water use permit application process is to provide the BCPUD Board of Directors the opportunity to evaluate the potential impacts of the project on water use at the property; this is part of the district's ongoing duty to carefully manage its limited water supply. More information about the BCPUD's water use permit process can be found in Resolution 655, found on our website at https://bcpud.org/administration/resol

utions/.

Our records indicate that a permit was issued in January of this year and therefore we ask that you bring the project to the BCPUD board for evaluation of the potential impact on water use at the property. Our next regularly scheduled board meeting is Wednesday, April 16, 2025, at 6:00pm. Please let us know if you can attend that meeting. If not, the meeting in May is scheduled for the 21st. Prior to attending the meeting, we ask that you fill out and return the upper portion of the attached LWUP application, along with a copy of any plans related to the project.

Georgia will be reaching out in the next day or so in response to your phone call regarding your septic system and our sewer system.
