#### SPECIAL REPORTS OR UPDATES—No Action Requested

9. Update on Project to Address Hazardous Roadside Trees in Partnership with Bolinas Fire Protection District (BFPD) and Marin Wildfire Protection Authority (MWPA) (1:20:40)

Ray Moritz of Urban Forestry has begun identifying trees that pose hazards related to emergency ingress and egress; the resulting report will be submitted to MWPA to address these trees; BFPD is on board for this approach.

#### 10. BCPUD Sign Area at Mesa and Olema-Bolinas Roads (1:34:26)

Discussion of best use for sign area at Mesa and OB Roads; decision is made to reserve this space for BCPUD-related signage with urgent/drought messaging; Board grants GM Woods/BCPUD staff discretion to mount signage without Board approval.

#### 11. Leak Relief Policy & Procedures Discussion (1:51:50)

Review of existing/historical leak relief policy; GM Woods recommends the Board consider amending leak relief resolution at future Board meetings to include: putting a cap on the number

of times each customer can be approved to receive leak relief; setting a minimum leak relief threshold; incentivizing customer purchase of Flume or other similar water monitoring device. Consideration of delaying revision of leak relief policy until automated water meter readers are installed; Board decides to revisit these issues at November meeting.

# LWUP Policy and Procedures Discussion (2:02:25)

Review of existing/historical limited water use permit (LWUP) policy; discussion of possible enforcement mechanisms for LWUP exceedances; possibility of revising existing LWUPs for consistency in maximum quarterly allowance; suggestion to revise policy determining what conditions or situations trigger an LWUP. GM Woods recommends holding off on overhaul of LWUP resolutions until transition to automated water meter readers is complete. Board will revise LWUP policy revisions in December.

# 12. Proposed Road & Ditch Maintenance ROW Issues (2:22:08)

Review of management of ROW on the Gridded Mesa and consideration of amendment of Ordinance 30 at future Board meeting.
