2. **Board Consideration of Approval for District to be a Signatory on the Alliance of Coastal Marin Villages' Letter to County Executive Office Regarding Sea Level Rise Planning (12:09)** GM Woods explains the letter is asking for delegated county representation to focus on sea level rise issues in West Marin; Director McElroy suggests revising the letter to include additional state and federal agencies that will be involved, emphasizing the complexity of the project.

3. **Update on Eucalyptus Removal Project in Coordination with Bolinas Fire Protection District, Utilizing Governor Newsom's State of Emergency Executive Order for Hazardous Tree Removal (22:16)** GM Woods shares a [memo](#) with updates on hazardous tree removal and clarifies the distinction between the hazardous tree removal project and the bike path project. BCPUD continues to work with Bolinas Fire Protection District (BFPD) to address hazardous trees in Zone 5; this project leverages Governor Newsom's emergency declaration, which suspends full Coastal Commission and CEQA reviews. BCPUD also plans to proactively manage smaller-diameter saplings (≤6 inches) through routine grove maintenance. This work will proceed independently of the emergency project. Updates will be provided to the Board and the public as this effort progresses.

Status of Bolinas Eucalyptus Project (BEP) (25:12) The BEP application remains under review by the County Environmental Permitting division. We are currently awaiting a formal cost estimate for CEQA-related reports from the County and their environmental consultants. Although the County Development Agency (CDA) marked the BEP application as "Complete," both CDA and the Coastal Commission had identified incompleteness items that BEP/BCPUD were still addressing when CDA issued its "complete" status. Environmental planners and CDA later advised that these items should have been resolved during CDA's review to facilitate the CEQA process. For additional background, please refer to the [May memo](#) explaining why the Board paused the BEP project and chose instead to pursue hazardous tree removal under the Executive Order in partnership with the Fire District and MWPA.

Bike Path Project (27:13) The bike path rehabilitation project is separate from the hazardous tree removal effort.

- Scope: Rehabilitation only; no tree removal is included in this project.
- Funding: BCPUD currently has approximately \$400,000 allocated for bike path rehabilitation and is actively pursuing additional funding to complete full restoration of the entire path.
- Interplay of Bike Path Project with Hazardous Tree Removal Project: Hazardous trees near the trail will be addressed through the Executive Order tree removal project; the Bike Path project will not delay or interfere with hazardous tree removal efforts.

GM Woods reviews May Memo regarding BEP/Bike Path/BFPD **(28:57)** The May memo outlined recent milestones of BEP/Bike Path Repair Project and made recommendations to the Board on how to move forward.

GM Woods summarizes current strategy for hazardous tree removal **(40:58)** BCPUD continues to work toward the goal of hazardous tree removal while implementing guidance received from County and Coastal Commission: targeted removal of the highest risk trees to reduce existing hazards in a phased approach. This strategy allows BCPUD to use MWPA funding to reduce immediate public safety risk without imposing significant costs on customers or delaying action for years.

Discussion is open to the public **(42:31)** Members of BEP and other community members ask questions about the Bike Path project and hazardous tree removal project; GM Woods explains reasoning for rebuilding a new bike path in the footprint of the existing path – to use the existing permit from 2007 for the work and to maintain grade. GM Woods reiterates the importance of coordinating tree removal with PGE and DPW; BCPUD's desire to perform more proactive management of smaller growth within Zone 5; BCPUD's hope to eventually remove all hazardous trees.

7. **Discussion on District Policy for Approving Speed Bump Installations in the Public Rights-of-Way on the Gridded Mesa (1:44:32)** GM Woods shares a [memo](#) to provide context regarding the installation of speed bumps on the Gridded Mesa. BCPUD and BFPD have undertaken more road repairs and have received increased inquiries from residents about slowing traffic on newly improved roads. GM Woods reviews existing Ordinances that govern public right-of-way on the Gridded Mesa and explains that under current ordinance language, installation of speed bumps does not require an encroachment permit, as long as the speed bumps conform to the specifications outlined (4 inches height, 10 feet long). GM Woods recommends the Board consider allowing residents to install speed bumps in front of their property without Board review or office approval. Discussion of the need for more specificity regarding speed bump size and location. GM Woods explains the goal of streamlining the process so a single permit can apply to various encroachments in the right-of-way (mailboxes, fences, speed bumps, etc.). Discussion of the BCPUD endorsing community member efforts to get the county to install speed bumps on their roads (Overlook/Elm/Grove).
8. **Review & Proposed Amendments to Ordinance No. 28 (Cross-Connection Control) (2:03:45)** GM Woods shares a [memo](#) explaining that there are new statutory mandates associated with improving/augmenting BCPUD's cross connection control program, which prevents backflow from customer connections (hot tub, swimming pool, certain fire suppression systems, etc.) into the public water system. New plan has to be approved in December and will include performing an extensive survey to determine which customers need a backflow device.
9. **Review & Amend Resolution No. 553 (Leak Relief) (2:16:29)** GM Woods shares a [memo](#) proposing revisions to Leak Relief Resolution No. 553, as requested by the Board during its October meeting. Discussion of existing leak relief process and how the proposed revisions would impact this process. Decision to delay leak relief resolution modification to December meeting.
